### **Reminder - Deadline to File Flex - January 15**

- Remember to get your reimbursement request in by the January 15, 2018 deadline to avoid losing any funds.
- If you were enrolled in a 2017 PEEHIP Flexible Spending Account plan in effect from October 1, 2016 through September 30, 2017, the filing deadline is quickly approaching. All reimbursement requests for expenses incurred by September 30, 2017 must be submitted to HealthEquity along with proper documentation no later than January 15, 2018.
- Remember any unused funds in excess of \$500 remaining in your Health FSA after the deadline cannot be refunded and will be forfeited. All unused funds remaining in your Dependent Care FSA after the deadline will also be forfeited pursuant to the – “use it or lose it” rule.
